## **The Singapore Declaration, December 2019**

**We, the landowners of intact tropical ecosystems in Papua New Guinea, with support of our global volunteers declare:**

For the benefit and survival of our sacred forests, lakes, rivers and seas, and all humans, flora and fauna, we pledge now and in perpetuity, when and if we receive the support we require;

1. To secure our land and marine-based biological resources and ensure any use is carried out in a sustainable way
2. To never allow over-exploitation, or unsustainable extraction of minerals, gas, oil, or coal
3. To ban commercial logging, and refrain from mono-culture industrial scale plantations
4. To sustainably maintain our lands, waters, and forests and the natural resources benefiting all inhabitants of our global biosphere
5. To implement ECOSHARE activities to enable extreme long-term conservation and use, and a lifesaving return to all people
6. To work in peaceful collaboration and mutual respect with and among each other, all local and national, and international governments, bilateral and multilateral organizations and as much as possible any individual, anywhere in the world, to make our ecosystems safe and protect our flora and fauna, while improving our livelihoods

We can and must start ECOSHARE now, as it is almost too late to maintain our beautiful forests and seas. We have no time to lose, if we act now we can still save a very significant part of the world's species rich, tropical ecosystems.

We have decided after deep consultation to entrust our biological assets to ECOSHARE Pte Ltd Company, incorporated in Singapore, under long-term extendable leases. Our terrestrial, freshwater and marine-based ecosystems will be held under these agreements beyond the year 2100.

In return, 85% of income from sales of ECOSHARE certificates will be spent in PNG on direct investment in small and medium-sized businesses, to conduct legally required surveys, to facilitate low and high tech protection and monitoring, and to support basic livelihood requirements, and PNG government efforts.

To realize the potential of ECOSHARE, we need investors to commit major contributions immediately. These funds will help improve the wellbeing of the participating Papua New Guinean communities, and support our country along the path to sustainable development. Many of us live a life of subsistence, heavily dependent on the often unpredictable bounty of our natural resources. This complex relationship often involves periods of food scarcity, lack of access to healthcare and general poverty. We want to break this cycle and pursue new development options: we cannot continue this desperate situation in which our children are dying, our rivers are dying, our forests are dying, and our seas are dying – all unnecessarily. The little cash income we can obtain today is mostly derived from mining, logging and other unsustainable activities.

Monetary valuation of natural capital confined in our ecosystems is the solution. We believe ECOSHARE is a win-win approach for everybody and will ensure a reduction of global warming and prevent ecosystem collapse. ECOSHARE certificates and shares, will dramatically increase in value over time, and all investors will create real, total ecosystem protection, and earn monetary rewards. Sustainable use of our bio resources will generate profits and help maintain the contributions from our lands and people to stabilize the global biosphere.
